- **Park Ranger Presentation**

- **Harry Dotson Park** - Chair Ontiveros had nothing to report.
- **Hollenbeck Park** – Director Roman reported on behalf of Chair Ontiveros and Commissioner Barrios that there is debris accumulating along the east and west block of walls adjacent to the decomposed granite trails on the north end of the park as well as the curb along Lola Ave. What is the timeline of replacing the broken single tidier totter in the playground?
