

**MINUTES OF THE PARKS, RECREATION AND COMMUNITY SERVICES COMMISSION OF
THE CITY OF STANTON

1. CALL TO ORDER

The members of the Parks, Recreation and Community Services Commission of the City of Stanton met in regular session in the City Council Chambers at 6:30 p.m., Chairperson Ontiveros presiding.

5. DIRECTOR'S REPORT

5A. COMMUNITY SERVICES DEPARTMENT

- **Public Works Presentation**

Director Rigg presented a slide presentation to the Commission on some past and present projects going on in the City.

Discussion followed

- **Commissioner Park Update**

- **Harry Dotson Park** - Chair Ontiveros had nothing to report.
- **Hollenbeck Park** - Chair Ontiveros and Commissioner Barrios reported on the dead vegetation on the nursery side of the park. They also reported that the

teeter totter at the park needed to be repaired. Director Roman informed the Commission that the part was reordered due to a sizing issue. Chair Ontiveros reported that the trees located between both playgrounds need to be trimmed.

- **Premier Park** – Vice Chair Warren reported that there were some cracks in the sidewalk towards Chapman Ave.
- **Stanton Central Park** - Commissioner Lacayo had nothing to report.
- **Stanton Community Services Center** – Commissioner Henry had nothing to report.
- **Stanton Park/Norm Ross Sports Complex** – Vice Chair Warren reported that the chain link fence going into the Norm Ross field needed to be repaired. Also 2 light posts do not light up at night. Director Rigg commented that 2 light posts needed to be repaired and would be up and running soon.
- **Veterans Park/Martha Weisaupt Park and Linear Parks** – Commissioner Himes reported at Veterans Park the grounds look like it needs to be power washed and a planter area located in the back is very dry. At Martha Weisaupt, most of the roses in the front area are dead and dry. By the edge of the train tracks there is some graffiti on a curb.
- **Zuniga Park** – Commissioner Heitman commented that the park was well taken care of.
- **Beach and Orangetown Pocket Park** – Vice Chair Warren noted that there was some trash in some areas of the park.

- **Easter Egg Hunt, Pancake Breakfast and Resource Fair Re-cap**

The Easter Egg Hunt was a huge success; it was scheduled on Saturday, March 31, from 9-11 a.m. at Stanton Central Park. There were over 18 vendor booths offering services to the community. The pancake breakfast did very well with all the proceeds going to the Youth Assistance Foundation for the Santa Siren program in December.

- **Mayor's Prayer Breakfast Re-cap**

The Mayor's Prayer Breakfast event was held last Thursday, April 12th from 7:30 – 9:00 a.m. at the Knott's Berry Farm Hotel. All proceeds went to the Stanton Community Foundation which raised over \$22,000 to help families, youth and community programs.

- **The 17th Annual Car Show**

Director Roman informed the Commission about the upcoming Car Show event on Saturday, May 12th from 9:00 a.m. to 12:00 p.m. at Stanton Park. There are currently 50 cars pre-registered for the event. Commissioner Ontiveros informed Director Roman to add 35-40 more cars to the pre registered list.
