The Mayor's Fitness Challenge will take place on Friday, July 6th from 6:00 to 8:00 p.m. at Stanton Central Park. The Mayor's Fitness Challenge event is designed to provide fitness activity for the community. PARK UPDATES

- o Harry Dotson Park Chair Ontiveros had nothing to report.
- Hollenbeck Park Chair Ontiveros would like a follow up on the 2 trees located on the north side of the park on whether they will be replaced or removed.

Update at Hollenbeck Park: The delivery date for the spiral slide 4 to 6 weeks. The drinking fountain that was clogged with sand was drained and Staff will continue to work on getting it repaired.

Premier Park – Vice Chair Warren had nothing to report.

Update at Premier Park: A new vendor has been contacted to repair the playground equipment rather than to completely remove it. It's scheduled to be repaired within 3-4 weeks.

- Stanton Central Park Commissioner Lacayo had nothing to report.
- Stanton Community Services Center Commissioner Henry had nothing to report.
- Stanton Park/Norm Ross Sports Complex Vice Chair Warren reported graffiti on the park sign near the entrance. One of the trash cans is missing near the exercise equipment shelter area. There was a hole in the fence in the middle area of the park and also on the bridge crossing over to Norm Ross Field. One of the benches in the park is uneven and needs to be adjusted. Also, there is a utility box by the back stop that is open. It is located in an isolated area not along the walking path. Lastly, at the front of the park, there is a board missing near the water dam.

Update at Stanton Park: The fence has been repaired near the Norm Ross Field entrance. The gopher holes have been addressed by Venco Landscaping. There were 5 new light poles that have been replaced and minor repairs to the playground slide.

 Veterans Park/Martha Weisaupt Park and Linear Parks – Commissioner Himes reported that Veterans Memorial is in need of a power wash on the paving areas. At Martha Weisaupt Park, there is some graffiti on the northwest end of the park by the train tracks.

Update at Veterans Memorial Park: A Light pole was repaired and reinstalled. Light bulbs were ordered and will be installed on Monday, April 23rd to replaced a total of 11 light bulbs were out. The landscaping issues were addressed by staff with the Venco to take care of items on the list that needed attention. At Martha Weisaupt Park, a dead tree was removed and new plants to replace the dead rose bushes. The debris along the railroad was picked up on April 23rd.

- o **Beach and Orangewood Pocket Park** Vice Chair Warren had nothing to report other than grass growing in the bark.
