5. **DIRECTOR'S REPORT**

5A. COMMUNITY SERVICES DEPARTMENT

PARK UPDATES

- o Harry Dotson Park Chair Ontiveros had nothing to report.
- o Hollenbeck Park -Chair Ontiveros was happy to report that the slide was fixed at the park by Public Works. The trees along Lola that were removed because they were dying. Will they be replaced with new trees?
- o **Premier Park** Vice Chair Warren reported that the graffiti problem at the park has been handled and the park is graffiti free.
- o **Stanton Central Park** Commissioner Lacayo reported some shoes hanging from the electric wires right above the main entrance.
- o Stanton Community Services Center Commissioner Henry reported on the new fencing and her only concern was over the fencing along the parking lot side. Kids play ball close to the fence and might try to jump the fence to retrieve the ball.
- o Stanton Park/Norm Ross Sports Complex Vice Chair Warren reported that the signs by the demonstration garden near Beach Blvd. are loose or broken. There are birds in the new LED lights, maybe anti birds measures can be installed on them. Vice Chair Warren wanted to say thank you for clearing the RV in the parking lot area and the new exercise signs look good.
- Veterans Park/Martha Weisaupt Park and Linear Parks Commissioner Himes reported that the linear park between Katella and Rose has a pile of tree trimmings from the house behind the park. At Veterans Memorial Park, there was food on the benches and weeds coming up through the pavers. At Martha Weisaupt Park, there is trash in the bed along the railroad by the back edge of the park.
- Zuniga Park Commissioner Heitman mentioned that the park is very well taken care of by the community. Some residents have asked about having a horseshoe pit at Zuniga Park.
- o Beach and Orangewood Pocket Park Vice Chair Warren had nothing to report. A resident of 35 years contacted Vice Chair Warren and mentioned how much he loved the newly remodeled park. His only concern is how visible the lettering is driving on Beach Blvd. Assistant City Manager, Stephen Parker mentioned that a lighting feature will be installed at the park once the plan is finalized.
