5. MANAGER'S REPORT

5A. COMMUNITY SERVICES DEPARTMENT

FACILITY UPDATES

Community Services Manager, Zenia Bobadilla updated the commission of facility updates. At Premier Park there was a safety issue with the merry go round playground equipment so it has been removed by Public Works. The City is

exploring purchasing some more playground equipment with park in lieu fees or through the Prop 68 grant.

18th ANNUAL CAR SHOW & KIDS FAIR

In partnership with the Stanton Community Foundation, the 18th Annual Car Show was held on Saturday, May 11th. There were over 85 cars registered and 20 vendors selling a variety of items. The money raised by the Foundation will be used to support the SOS grant program, Threads 4 Kids and senior activities.

SENIOR RESOURCE EXPO

The Senior Resource Expo will be held on Tuesday, May 21st from 9:00 – 11:00 a.m. at the Stanton Family Resource Center. There will be a variety of health screenings and information resources for seniors. This event is free to all seniors 55 and older.

SUMMER KICK-OFF

On Saturday, May 25th from 11:00 a.m. to 2:00 p.m. the City will host its annual Summer Kick Off event at Stanton Central Park. There will be music, food vendors and community groups sharing resources. This event helps to promote the opening of the splash pads at both Stanton Central Park and Harry M. Dotson.

7. <u>NEW BUSINESS</u>

7A. DISCUSSION REGARDING DECORATING UTILITY BOXES THROUGHOUT THE CITY

Community Services Manager, Zenia Bobadilla introduced Community Services Coordinator, Kelsey Ransom who will be detailing some options for utility boxes throughout the city.

On Monday, February 25, 2019 the Parks and Recreation Commission discussed and addressed a potential program to begin decorating utility boxes throughout the city. Research was conducted regarding the potential cost to start and maintain the program. The cities of Davis, Glendale, Downey and Redondo Beach have established funding by creating a Public Art Fund. The funds are collected from 1 percent of the project value for new buildings valued at \$500,000 or more, not including industrial or residential zones or projects financed through public funds. The artwork was also mainly allowed on city owned projects financed through public funds. The City currently owns 26 utility boxes. Any artwork to be done on a public utility company's box requires a contract and approval between the city, artist, and utility company.

7B. DISCUSSION REGARDING LOVE OUR CITIES/STANTON CLEAN UP DAY

Community Services Manager, Zenia Bobadilla introduced Community Services Coordinator, Dianna Valtierra to discuss a Community Service Day / Love Our City concept.

On Monday, February 25, 2019, the Parks and Recreation Commission discussed adding a service-based program like Love Our Cities or a similar model in Stanton. The information was collected including a cost analysis if the City were to adopt the Love Our Cities model or create an independent program that still focused on service to the community. There are currently 11 Orange County cities involved in the program. The faith based group that partners with these Cities is OC United. They describe their program as a movement to improve cites such as Anaheim, Brea, Buena Park, Costa Mesa, Fullerton, La Habra, La Mirada, Orange, Placentia, Tustin and Yorba Linda with the help of thousands of volunteers from churches, schools, city government, local businesses, organizations and other community groups. The minimum cost to join the Love Our Cities program would be \$750 in addition to staff time to coordinate with the partner agency.
